THE COUNCIL OF MINISTERS ANNOUNCES A QUARANTINE IMPOSED ON TRAVELLERS

ARRIVING TO FRANCE EXCEPT FROM UE & UK

USPA NEWS - On Saturday, a special, "educational" council of ministers was held at the Elysee at 11:30 am because the government is to decide to extend the state of health emergency for two months. This bill is the legal basis for the after 12 months, imposing new measures and recommendations, including a bill to extend the state of emergency until July 24. Quarantine for French or foreign people arriving from abroad. The French meanwhile, and people already present in France are not subject to this quarantine, in a non "compulsory" manner, but as explained by the ministers present, this measure for those resident and present in France. The three ministers, Olivier Veran, de la Sante and Christophe Castaner de l'Interieur, and Sibeth Ndiaye, Secretary of State to the Prime Minister, government spokesperson are present to answer questions from journalists, (representatives by a single journalist Elenore Payro Journalist at LCI TV relayed questions from other accredited journalists of the Elysee) very numerous as for the preparation of the beginning of the lifting of confinement, which will take place on May 11.

Since the announcement of the obligation to wear a mask in public transport by the Prime Minister on April 28 at the National Assembly, the Minister of the Interior completes this announcement by explaining that and the sworn agents of the SNCF, will be authorized to make checks and empowered to apply sanctions, in the event of not wearing a mask. On the other hand the CEO of the SNCF, has meanwhile announced that travelers without masks will be denied access to trains, while adding that the SNCF lost € 2 billion, plunging the railway company into a very difficult period, because it had already experienced another deficit of € 1 billion, following the strikes of the Yellow Vests of the strike against the pension reform.

Concerning the gatherings, they will be prohibited, from 10 people, from the beginning of the ease of lockdown which is a priori planned for May 1.

A parliamentary debate with articles to be discussed and a number of amendments likely to be addressed in the coming days before the face to face of Prime Minister Edouard Philippe with the Senate, which will take place Tuesday, May 5, to reveal the modalities of lifting of containment. In order to break the transmission chains, around 14 days will be imposed on travelers coming from abroad, except for those coming from the Schengen area (EU and UK), whatever their nationality.

Minister for Interior Christophe Castaner Remarks : « We were able to save lives and plan your health system thanks to containment and your behavior. The firefighters and the police and gendarmes who enforced the containment measures and I also thank the prefects. On May 11 (fixed date for the start of the lifting of containment) we are entering a new phase to resume our lives patiently and carefully, in the coming weeks and the health bill, which will extend the state of health emergency until July 23 to act quickly and efficiently. this text is based on the civic spirit of the french it is imperative and it is one of our ability to our success.

Minister for Health Olivier Veran Remarks : An executive order has been adopted for an aid device for liberal health professionals and

especially for equipment. Certain activities for physiotherapists and dentists have been reduced to 50% and the aid will cover the costs of their activities to resume normal activity and in the best conditions. The bill of the State of emergency of Health, presented in the Council of Ministers Minister will be extended until July 24, which Including in the bill, a legislative framework with the parliamentary examination and in the course of the stages of lifting lockdown which will take place little by little. The government's word has been very clear, it will not be a waste of time. We will have to live with the virus as the PM said. We will focus on the challenges of containment and continue to swim against the virus. QUARANTINE Jurisdictional guarantees because this trial is based on membership with confidence. There are 3 fields of measures, which may not be compulsory, except to arrive in the territory or in Corsica or DOM TOM (Overseas territories), the conditions, duration of place and health monitoring and conditions of exit and which will be assessed by the board of health. The ARS, will fix the new measures and will be presented to the Judge of liberties and detentions who can be seized. The quarantine could not be more than 14 days, of isolation and cannot exceed 30 days. Travelers who refuse these prophylactic methods and risk contaminating others have not been selected.

We trust the civic spirit of people, and the will to reduce the circulation of the virus on the territory. The data collected will be medical with 5 stages: 1- data collection by laboratory, 2 / level 1 tracing, in town as in hospital to define the circle of contamination and beyond this circle, there will be a prophylactic tracing. Tracing 3 is done by the ARS about the virus circulation routes, namely the clusters and the health instructions will be followed, by public health, and the health directorate. The purpose of this information is to collect information necessary to reorganize biological changes and screening to reduce the spread of viruses, the files are sensitive and protected by medical secrecy. The data will not be used in a digital application, just to allow doctors in hospitals and in the city to form "Guardian Angel Brigades", and have access to adequate data to protect the sick. The COVID-19 contacts, and via the Ameli website, will make it possible to assess the contacts of the people to be contacted, with advice, the public in preparation with the CNIL, we are more in a medical approach than collecting personal data. We are aware of the professional, social, personal family efforts required of all of you, which seem to be impossible, and propellants must be scrupulously respected to reduce and defeat this virus and we will defeat this virus. " Minister for Health Olivier Veran, declared.
